- **A. BVES 6th Grade Report on Washington DC:** Students presented a slide show and video from their trip to Washington DC in December. They visited war statues and memorials, road the metro, saw the State Christmas Trees, Arlington Cemetery, Robert E Lee Mansion, met with Chris Stewart, Holocaust Museum, Hard Rock Café, Ford's Theatre and watched a Christmas Carol play, White House tour, Capitol tour, Smithsonian, Botanical Gardens, Air & Space Museum, participated in Night walks to see the monuments, Natural History Museum, LDS Temple lights and nativity, Mount Vernon, George Washingtons house, and National History Museum. All were very educational for the students. The 6th grade class is very appreciative of the donation from the city for the trip. BVES will continue to do the trip each year.

- **B. Sherriff Houston Report:** He will report next meeting.
- **C. Street Banner Arms Purchase:** Banner arms will cost around \$60/each. They have arrived. Will try these and see how they hold up.
- **D. Shot Clock follow Up:** Blake Electric has not given a bid yet. The clocks are working, just need to be hard wired.
- **E. Paving Road to Apartment/Housing area:** Mayor presented the map of the roads that need to be paved. There is a portion in front of the Grand Hotel that is sluffing off and will need to be fixed. The green areas on the map are the priority areas. Each section will be bid out separately. Klay is aware of the drainage, and they will work on keeping drainage out of the employee housing. Mayor will attend the next Ruby's Inn board meeting and discuss the plan with them. The other area that needs to be paved is the road to Tim Leech's house. Will need to get an engineer down here to get a description of the properties and survey the areas. Right of aways for Ruby's Inn utilities and water will be part of the plan. Deanna mentioned there was a fire hydrant that was buried in snow, but someone cleared it out. May need a large pole to mark them for the years we get lots of snow, so they do not get plowed over.

- F. Meet Bryce Canyon City Town Council & Resident Dinner Planning: Committee met along with several residents. The original plan was the hold the dinner on March 8th, however that will not work for all the council members so it will be moved to March 7th. The theme will be a Hawaiian Luau held at Ebenezer's Barn & Grill. Invitations will be sent out to the residents. The dinner will begin with an introduction at 5:30PM. Then dinner will be at 6:00PM. The residents brought up that March 8th is a day of recognizing women in some countries, so there will be something to honor the women that night. Will introduce the city council and family residents to one another. Food will be ordered from Mo Bettas from Cedar. Will cost around \$10/person. Estimated \$2000 total for the meal. There will be a closing program around 7:15PM on what the city provides for the residents. Will also discuss the road paving projects around the housing area. The original founding members of the Bryce Canvon City will be honored that night. Jade brought in sample invites. She will get a copy translated into Spanish if they are approved. Jade also presented a program that will sit on the table so residents will know that there is more than just dinner. We want them to stay for program. Will need to purchase some table center pieces, leis, back drop for a photo area, flower straws for drinks, and a few beach balls. Will order chocolates for the women to honor them. Estimated \$225 in supplies. Mike makes motion not to exceed \$300 for the supplies, 2nd by Gary, Kam yes, Bryce yes Ruby's Inn will submit a bill for the facility and catering.
- **G. Syd Municipal Clerk Certification/Conference, UGFOA Annual Conference:** The Utah Municipal Clerks Association has set up a new certification for clerks. The training will be held April 3rd-7th at SUU in Cedar City. However, there is a virtual option so there will not be any travel costs. The certification is achieved by several steps.
