Bryce Canyon City Sales Tax 7.35% Bryce Canyon City Resort Tax 1.10% Bryce Canyon City Arts&Zoo (RAP) 0.10%

Transient Room Tax 5.57% (this applies to ALL nightly rental facilities, i.e.

(Motel/Hotel rooms, vacation rentals, bed and breakfasts, cabin rental, etc.)

Restaurant Tax 1.00%

## Examples:

If you operate a nightly rental business, please ensure the total tax being charged is 14.12% (Sales 7.35% +Resort 1.10% +Arts & Zoo(RAP) 0.10% + Transient Room Tax 5.57%)

If you operate a restaurant your total tax on food should be 9.55% (Sales 7.35% +Resort 1.10% Tax+Arts & Zoo(RAP) 0.10% +Restaurant Tax 1.00%)

If you sale a product your total tax on products should be 8.55% (Sales 7.35% +Resort 1.10% Tax+Arts & Zoo(RAP) 0.10%)
